Dear Mr. King,

I received an email forwarded from Mr. Steve Carmack regarding file uploads to the State Geotracker website for the subject fuel leak case. I am not aware of the specific files uploaded, but wish to convey that each groundwater monitoring and sampling report typically generates four files for upload to Geotracker. First is the complete report itself, second is the EDF file containing laboratory analytical data, third is the GEO_WELL containing depth to groundwater, and a GEO_MAP figure for the site depicting groundwater contours and flow direction, ideally with text boxes summarizing the concentrations of contaminants in groundwater. Every groundwater monitoring well should have a GEO_BORE lithology log with well construction detail, GEO_XY and GEO_Z coordinates.

Similarly, soil and groundwater investigations generates at least four files for upload to Geotracker. First is the complete report itself, second is the EDF file(s) containing laboratory analytical data, third is the GEO_BORE lithology log for each boring, and GEO_MAP figure(s) for the site presenting the locations of the borings, ideally with text boxes summarizing the concentrations of contaminants in soil and/or groundwater.

As I do not have an email address for Mr. Carmack, if he is the contact consultant for the subject case, ACEH is requesting you provide his email address so that we can correspond quickly and efficiently regarding your case.
