The document did not provide documentation indicating that any remaining investigation, remediation, and well destruction derived waste (IDW) have been removed from the site, as was requested the Alameda County Environmental Health (ACEH) letter dated May 5, 2015.

The report needs to be resubmitted with acceptable IDW language and, if appropriate, documentation.
