ACEH has reviewed the well destruction report. The report states that well destruction debris has been removed from the site and disposed at a state-licensed waste disposal facility. The report did not include documentation of this action. Because the debris included soil and annular materials (more than just the surface well box nominally characterized as construction debris), ACEH would request documentation of offsite disposal. Please advise if the State would like ACEH to followup with the consultant and RP.
