			The corrective Action Plan is to determine the anomalies which may be potential USTs that were discovered during a Geophysical Survey conducted in 1999, however these costs are not eligible for Funding per Fund Regulation 2812.2(d)(3), Regulation 2904.
	Over Excavation Project	\$ 0	Secondly, the once highest groundwater contamination in on-site GWMW MW-3 declined significantly (from a high of 120,000 ppb TPH(g) and 4,600 ppb benzene in 1993 to a low of 78 ppb TPH(g) and Non detect for Benzene in 2007, which are below the ESLs for Region 2, which shows that natural bio-degradation has occurred at the site and continues to occur.
			Thirdly the CAP is based on one soil sample high hit in SB-4 at 15' bgs, yet there has been no recent investigation to determined if it exists nine years later or there has been no investigation to define the extent of over excavation limits. At this time, this scope of work may be pre-mature, unreasonable and unnecessary.
			The Claimant may choose to continue with the proposed cost at own cost without any expectations for reimburesements per the approved scope of work.
