During the detailed review of your application, Fund staff has determined that your claim for the subject site is not eligible for reimbursement from the Fund. We notified you on July 11, 2012, that you were not in compliance with regulatory agency directives from Alameda County and were given 90 days to obtain compliance. Dilan Roe from Alameda County has confirmed that you are still not in compliance with the requirement to upload data and reports to GeoTracker.

Pursuant to Section 2813.3 of the Fund Regulations, your claim is suspended from the Priority List based on the following reason:

**Failure to comply with directives issued by regulatory agency.**

If you disagree with this Staff Decision, you may appeal to the Fund Manager pursuant to Section 2814 of the *Petroleum Underground Storage Tank Cleanup Fund Regulations*. A request to the Fund Manager must include, at a minimum: (1) a statement describing

how the claimant is damaged by the prior Staff Decision; (2) a description of the remedy or outcome desired; and (3) an explanation of why the claimant believes the Staff Decision is erroneous, inappropriate or improper.

If you do not request a review by the Fund Manager within 30 calendar days from the date of this letter, the Staff Decision will then become final and conclusive and your claim will be removed from the Priority List at the end of the 30-day period.

If you correct the grounds for suspension, your claim will be reinstated to its previous placement on the Priority List.
