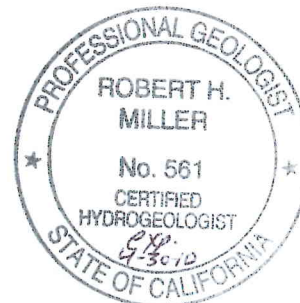

WORK PERFORMED THIS QUARTER (Second Quarter 2009):

1. Prepared and submitted *First Quarter 2009 Status Report* (BAI, 4/30/2009).
2. Continued attempts to track down and contact Mr. Curtis Thomas and Ms. Joyce Thomas.
3. No environmental field work was conducted at the Site during the Second Quarter of 2009.

WORK PROPOSED FOR NEXT QUARTER (Third Quarter 2009):

1. Prepared and submitted this Second Quarter 2009 Status Report (contained herein).
2. Continue to seek involvement of co-responsible parties to implement approved field work.
3. No environmental field work is scheduled at the Site during the Third Quarter 2009.

DISCUSSION:

In a letter dated 16 October 2008, ACEH stated that Atlantic Richfield Company (a BP affiliated company) should still be considered a Responsible Party for this Site despite the fact that Atlantic Richfield Company refuted this status in letters dated 20 June and 4 September 2008. The 16 October 2008 ACEH letter also requested the completion of a soil and groundwater investigation as previously approved in the ACEH letter dated 22 June 2006. The approved *Work Plan – Monitoring Well Installation, 1450 Fruitvale Avenue, Oakland, California* had been prepared by AEI Consultants for Fruitvale-Farnam Associates, LLC and was dated 3 March 2005. Atlantic Richfield Company has attempted to contact the other listed co-Responsible Parties in order to collectively implement the approved scope of work. However, this endeavor has resulted in limited success. Mr. & Mrs. Curtis and Joyce Thomas cannot be located or contacted. According to Mr. Ken Phares in care of Jay Phares Corporation (who is apparently no longer a co-RP), Mr. Bill Puha (Fruitvale-Farnam Associates, LLC) wants no involvement with the release cleanup and is not interested in sharing cleanup costs. Atlantic Richfield Company has asked Mr. Phares whether Mr. Puha might be interested in applying to the California UST Cleanup Fund. Atlantic Richfield Company has directed Mr. Eric Holm of Delta Environmental Consultants, Inc. to send Mr. Ken Phares information on the Cleanup Fund and to assist him with pursuing coverage for Mr. Puha/Fruitvale Farnam Associates LLC. Another option being explored is using private investigators to locate Mr. & Mrs. Curtis and Joyce Thomas for the purposes of having one of them sign a cleanup fund application as claimant. Further updates of co-Responsible Party status will be provided to ACEH when new developments or information becomes available, but at least on a quarterly basis.
