Alameda County Environmental Health (ACEH) staff has reviewed the case file for the above-referenced site including the recently submitted reports entitled, "Human Health Risk Assessment for Call Mac Transportation at 461 McGraw Avenue, Livermore, California," dated June 3, 2008 and "Remedial Action Report, 461 McGraw Avenue, Livermore, California," dated June 3, 2008. The "Human Health Risk Assessment for Call Mac Transportation at 461 McGraw Avenue, Livermore, California," dated June 3, 2008 concluded that the total cancer risk posed to commercial occupants of the proposed building by chemicals in soil gas are within the USEPA acceptable risk management range of 1x10⁻⁷ to 1x10⁻⁴. The "Remedial Action Report, 461 McGraw Avenue, Livermore, California," dated June 3, 2008 documents remediation of tetrachloroethene (PCE) contamination in soil and groundwater at 461 McGraw Avenue and recommends case closure based on reductions in PCE concentrations in soil and groundwater.

The case is currently under review for case closure by ACEH. During the review for possible case closure, groundwater monitoring may be suspended. Following completion of ACEH review and California Regional Water Quality Control Board concurrence, the case will be closed or ACEH will provide further directives for additional information, investigation, or cleanup.
