I also left you a voicemail this morning. Mariner Square Group, an RP, has retained Environmental Technical Services (ETS) to satisfy the requests documented in your letter dated June 17, 2011, "Notice of Violation; Fuel leak Case No. RO0000313 (Global ID #T0600101566), Chevron #21-1663/Mariner Boat Yard, 2415 Mariner Square Drive, Alameda, CA 94501". Please be aware that the Mariner Boat Yard, a yacht dealer, has suffered severely during this economy.

ETS is searching through all historical files, scanning, and renaming them for electronic filing. We have also contacted ERM to determine if there is any missing data and we're waiting for their response. We have uploaded all documents to the Alameda County ftp site. We have obtained a Geotracker login and are processing the Responsible Party (RP) Claim Site access request with the RP.

The deadline for filing is today and we have completed the upload to the county site (13 files starting with RO000313), however, acquiring access for Geotracker is much slower (3-5 days is "normal"). I am hoping that uploading to the county site and initiating the Geotracker filing process satisfies the July 29, 2011 requirement. We will upload to the Geotracker site as soon as we are given access. We have also started work on the Remediation Progress Report due September 2, 2011
