Excavation Activities at PACO Pumps' 9201 San Leandro Street Facility

Dear Barney:

We have just received the results of the soil samples collected on August 3, 1992. This sampling effort is associated with excavation activities at PACO Pumps' 9201 San Leandro Street facility. As you can see in the attached figure, elevated concentrations currently still exist. Our recommendations are to continue excavating the walls of the excavation down to 8.5 feet below the surface. The recommended extent of excavation for this round of activities is presented in Figure E-1. We are currently limited by the proximity of the building and do not recommend excavating closer than four feet from the foundation. Please review our recommendations and call with your determination. We would like to continue our excavating activities on Monday, August 10, 1992.

If you wish to pass this site on to another of your colleagues, please have them contact us with their determination. But we do enjoy the experience of working with you personally. We also understand the agency is currently undergoing a reorganization.

Myself and Mr. Scott Liddicoat, of PACO Pumps Inc., would like to meet with you, or the appropriate agency representative, to discuss future actions at PACO Pumps' 9201 San Leandro facility. If possible, we would like to meet in your office on Friday, August 14, 1992, at 10:30 A.M. Please call to confirm your availability for the time and date of this proposed meeting.

The Work Plan for PACO Pumps' 845 92nd Avenue facility will be undergoing review by PACO Pumps and will be sent to the agency after the company has completed their review.


