
1.0 INTRODUCTION

All Environmental Inc. (AEI) has prepared this final report to document the contaminated soil overexcavation performed at 762 Harrison Street in Oakland, California (Figure 1: Site Location Map and Figure 2: Site Plan). The overexcavation activities were performed at the request and under the direction of Mr. Dale Klettke of the Alameda County Health Care Services Agency (ACHCSA).

2.0 BACKGROUND

On October 6 and October 9, 1995, AEI removed four gasoline tanks (Tanks A, B, C, D) and one waste oil tank from the property (Underground Storage Tank Removal Final Report, October 8, 1995). The tanks were transported as hazardous waste to the Erickson Disposal Facility where they were cleaned and disposed of as scrap metal.

The removal of the four gasoline tanks produced a single excavation. Analyses of samples collected from the gasoline tank excavation indicated up to 470 parts per million (ppm) Total Petroleum Hydrocarbons (TPH) as gasoline present in the soil. Laboratory results of representative soil samples indicated that the majority of the contamination was located near the east ends of Tanks B and D. Two stockpiles (N-STKP, S-STKP) were created from the removal of the gasoline tanks. Composite samples collected from the stockpiles were labeled N-STKP (A-E) and S-STKP (A-E). Analysis of the stockpiled soil samples revealed up to 94 ppm TPH as gasoline present in S-STKP (A-E). Samples collected from stockpile N-STKP were non-detect for all major constituents analyzed. Soil samples collected from beneath the waste oil tank revealed only minor levels of Total Oil & Grease (TOG) contamination, however 340 ppm TOG

was discovered in soil samples collected from the stockpiled soil produced during the waste oil tank removal.

On December 13, 1995 and December 14, 1995 at the request of ACHCSA, AEI overexcavated and disposed of contaminated soil from beneath the previous gasoline underground storage tanks. Stockpiled soil from the waste oil tank removal and stockpile S-STKP were profiled and disposed of the Vasco Road Sanitary Landfill during the overexcavation activities. Upon approval from the ACHCSA, N-STKP was reused as backfill material after the completion of overexcavation activities. The following report outlines the activities associated with the overexcavation and disposal of the contaminated soil.

3.0 PERMITS

On December 6, 1995, Mr. Dale Klettke of the ACHCSA was contacted regarding the scheduled overexcavation activities. Cal OSHA and the Bay Area Air Quality Management District (BAAQMD) were notified of the excavation plans. The excavation areas were marked and the property representative was notified of the specific time plan.

Copies of the permits and notification documents are located in Appendix A: Permits and Notification Documents.

4.0 OVEREXCAVATION OF CONTAMINATED SOIL

On December 13, 1995 the AEI work party was briefed, and the Health and Safety Plan (Appendix B) was reviewed prior to the initiation of work. Stockpile S-STKP was profiled and disposed of at the Vasco Road Sanitary Landfill on December 13, 1995. Approximately 100 tons of soil were transported and disposed. The soil was disposed of prior to the overexcavation activities in order to create room for the newly excavated material.

On December 13, 1995 and December 14, 1995, AEI removed approximately 430 tons of contaminated soil from the gasoline tank excavation. Two stockpiles were created from the overexcavation activities, and were place north and south of the excavation. Soil samples collected from the stockpiled soil were designated STKP 1-4, STKP 5-8 and STKP 9-12. Samples collected from the southern stockpile were designated STKP 1-8 whereas samples collected from the northern stockpile were designated STKP 9-12.

The original underground storage tank excavation was extended to a depth of approximately 20 feet below ground surface. Approximately 340 tons of soil were removed from the excavation. Groundwater was not encountered during the overexcavation activities.

5.0 SAMPLING AND ANALYSES

Confirmation soil sampling was conducted under the direction of Mr. Dale Klettke of the ACHCSA. A total of eighteen soil samples were collected and analyzed from the overexcavation activities. Seven discrete soil samples were collected from the excavation in the locations shown




on Figure 3: Sample Location Map. The language of the language. All sample locations are shown in Figure 3.

All soil samples were collected in stainless steel tubes which were driven into the soil until completely full, then sealed with aluminum foil, plastic caps, and tape. The secured sample tubes were placed into a cooler with ice. Chain of Custody documentation was initiated. The cooler and samples were brought to the AEI office and the samples were placed in a refrigerator. On December 15, 1995, the samples were picked up by McCampbell Analytical Laboratory personnel.

The samples were taken to Priority Environmental Labs (State Certification #1708) for chemical analysis. All soil samples were analyzed for TPH as gasoline (EPA method 5030/8015), Benzene, Toluene, Ethylbenzene, Total Xylene (BTEX) and Methyl Tertiary Butyl Ether (MTBE) (EPA method 8020), and Total Lead (EPA method 7240). The analyses are summarized below in the following table. Refer to Appendix C for analytical results and chain of custody documents.



6.0 CONTAMINATED SOIL PROFILING AND OFFHAUL

The overexcavated soil was profiled and accepted for disposal at the Vasco Sanitary Landfill in Livermore, California. The landfill required the analysis of one composite stockpile sample from the overexcavated soil to be analyzed for Reactivity, Corrosivity and Ignitability (RCI) prior to disposal. The analytical results for RCI are presented below in the following table.

Additional analyses of stockpiled soil originating from the waste oil tank removal were required prior to disposal. The additional analyses included CAM 17 Metals and Semivolatile Organic Compounds. These analyses were necessary to profile the soil for acceptance into the landfill. Analytical results for the waste oil stockpile samples are located in Appendix C.

On December 19, 1995 and December 20, 1995, approximately 430 tons of contaminated soil was loaded and transported, under non-hazardous waste manifest to the Vasco Sanitary Landfill for disposal. Copies of the non-hazardous waste manifests are located in Appendix D.

7.0 BACKFILLING AND RESURFACING

On December 19, 1995 and December 20, 1995, the gasoline tank and waste oil tank excavations were backfilled with clean imported material. Upon approval from the ACHCSA, the soil from the northern stockpile (N-STKP), which originated from the gasoline tank removal activities, was used as backfill material. The excavations were backfilled in one foot lifts and compacted to reduce long term settlement. The excavation was subsequently resurfaced by G&S Paving on January 3, 1996 and January 4, 1996 to match the existing surroundings.

8.0 SUMMARY AND CONCLUSIONS

On December 13, 1995 and December 14, 1995, AEI removed approximately 400 tons of contaminated soil from the excavation. Groundwater was not encountered during the overexcavation activities. Seven confirmation soil samples were collected from the excavation bottom and near the sidewalls. Analyses of the soil samples revealed the successful removal of the majority of TPH as gasoline and BTEX contaminated soil. Analyses revealed up to 5100 ppm TPH as gasoline remaining in the eastern side of the excavation. No additional overexcavation in this area is possible due to the presence and potential undermining of the site building. Analysis of sample OEB 20' revealed 290 ppm TPH as gasoline remaining in the northwestern corner of the excavation. All other confirmation samples analyses revealed minor or non-detectable concentrations of contaminants. The excavated soil was profiled and disposed of at an appropriate disposal facility. Additional soil from the tank removal activities was also profiled and disposed of off-site. Clean import was used to backfill the excavation. In addition, one of the stockpiles (N-STKP) originating from the gasoline tank removal was used as backfill material under the direction of Mr. Dale Klettke of the ACHCSA. The excavation was

resurfaced by G&S Paving on January 3, 1996 and January 4, 1996 to match the existing surroundings.

9.0 REPORT LIMITATIONS AND SIGNATURES

This report presents a summary of work completed by All Environmental, Inc. The completed work includes observations and descriptions of site conditions encountered. Where appropriate, it includes analytical results for samples taken during the course of the work. The number and location of samples are chosen to provide required information, but it cannot be assumed that they are representative of areas not sampled. All conclusions and/or recommendations are based on these analyses and observations, and the governing regulations. Conclusions beyond those stated and reported herein should not be inferred from this document.

These services were performed in accordance with generally accepted practices, in the environmental engineering and construction field, which existed at the time and location of the work.

Scope of Work: All Environmental, Inc. (AEI) will overexcavate contaminated soil in the vicinity of (4) previously remove gasoline underground storage tanks at the property located at the above address. The soil will be stockpiled on-site and disposed of off-site according to federal, state and local regulations. Soil samples will be collected to confirm the removal of the contaminated soil. The excavation will be backfilled and resurfaced to match the surrounding conditions.

There will be a three foot boundary surrounding the excavation pit and the stockpiled material. The area within this boundary is considered an exclusion zone and only qualified personnel will be allowed to enter. All personnel arriving or departing the site should log in before entering the exclusion zone. All activities on site must be cleared through the Site Manager.

D. HAZARD EVALUATION

Potential chemical hazards include skin and eye contact or inhalation exposure to potentially toxic concentrations of hydrocarbon vapors. The potential toxic compounds that may exist at the site are listed below with descriptions of specific health effects of each. The list includes the primary potential toxic constituents that may be found at sites which previously handled petroleum hydrocarbons, including home heating diesel fuel.

1. Benzene

- a. Colorless to light yellow, flammable liquid with an aromatic odor.
- b. Toxic hazard by inhalation, adsorption, ingestion and skin and/or eye contact.
- c. Exposure may irritate eyes, nose and respiratory system and may cause acute restlessness, convulsions, nausea, or depression. Benzene is carcinogenic.*
- d. Permissible exposure level (PEL) for a time weighted average (TWA) over an eight hour period is 1.0 ppm.

2. Toluene

- a. Colorless liquid with a sweet, pungent, benzene like odor.
- b. Toxic hazard by inhalation, adsorption, ingestion and skin and/or eye contact.
- c. Exposure may cause fatigue, weakness, confusion, euphoria, dizziness, headaches, dilated pupils, lacrimation, nervousness, insomnia, paresthesia, and dermatitis.
- d. Permissible exposure level for a time weighted average over an eight hour period is 100 ppm.

3. Xylene

- a. Colorless liquid with an aromatic odor.
- b. Toxic hazard by inhalation, adsorption, ingestion and skin and/or eye contact.
- c. Exposure may irritate eyes nose and throat and may cause dizziness, excitement, drowsiness, incoordination, corneal vacuolization, anorexia, nausea, vomiting, and dermatitis.
- d. Permissible exposure level for a time weighted average over an eight hour period is 100 ppm.

4. Ethylbenzene

- a. Colorless liquid with an aromatic odor.
- b. Toxic hazard by inhalation, ingestion, and skin and/or eye contact. Ethylbenzene is carcinogenic.*
- c. Exposure may irritate eyes and mucous membrane and may cause headaches, dermatitis, narcosis and loss of consciousness.
- d. Permissible exposure level for a time weighted average over an eight hour period is 100 ppm.

^{*} Known to the State of California to cause cancer.

5. Lead

- a. A heavy ductile soft gray metal.
- b. Toxic hazard by inhalation, ingestion, and skin and/or eye contact.
- c. Exposure may cause weakness, nausea, lassitude, diarrhea, insomnia, anorexia, inflamed mucous membranes and abdominal pains. Lead is carcinogenic.*
- d. Permissible exposure level for a time weighted average over an eight hour period is .05 ppb (in vapor).

6. Diesel

- a. Colorless to dark brown, combustible liquid with an aromatic odor
- b. Toxic hazard by inhalation, ingestion, skin and/or eye contact.
- c. Inhalation of vapors may depress the central nervous system, increasing reaction times, and decreasing pulse rate and blood pressure. Skin irritant.
- d. Occupational exposure limit 5.0 ppm (in vapor).

7. Gasoline

- a. Colorless liquid with a strong aromatic odor. Highly volatile and extremely flammable.
- b. Toxic hazard by inhalation, adsorption, ingestion and skin and/or eye contact.
- c. Inhalation of vapors can cause depression of the central nervous system with symptoms such as headache, dizziness, nausea and loss of coordination. Skin contact can cause defatting of the skin, skin irritation and dermatitis. Benzene is a major constituent of gasoline.
- d. Permissible exposure level for a time weighted average over an eight hour period is 300 ppm.

8. Waste Oil

- a. Toxic hazard by ingestion and possibly inhalation.
- b. Prolonged contact may cause skin irritation and dermatitis. Waste oil may be carcinogenic.*
- c. Waste oil may contain metals or toxic organics from thermal breakdown of the oil. In some cases, chlorinated solvents may be present.
- d. Permissible exposure level for a time weighted average over an eight hour period is 5 ppm (in vapor).

* Known to the State of California to cause cancer.

Dusty Roy has been designated to coordinate access control and security on site. All work will strictly follow OSHA guidelines. A safe perimeter has been established at a three feet radius surrounding the site. These boundaries are identified by yellow caution tape and orange safety cones. Personnel shall maintain the maximum distance from the pit while performing their duties. No one shall enter an excavation pit that is greater than five feet in depth unless the excavation is shored or sloped and no one shall climb on the stockpiled material except to cover it with plastic.

Additional hazards on site include heavy equipment and overhead lifting equipment. Heavy equipment used for performing the tank removal project may include a backhoe, an excavator, or a crane for lifting the tank out of the excavation. Only 40 hour trained personnel will operate equipment or perform any duty associated with this project. A hard hat and steel toed boots are mandatory for all personnel associated with the tank removal.

A FIRST AID KIT AND A 40 POUND BC FIRE EXTINGUISHER WILL BE AVAILABLE ON SITE.

EMERGENCY SERVICES ARE AVAILABLE BY DIALING 911 ON THE TELEPHONE LOCATED IN THE SITE MANAGER'S VEHICLE. THIS VEHICLE WILL BE ON SITE AT ALL TIMES.

E. PERSONAL PROTECTIVE CLOTHING

Based on evaluation of potential hazards, level "D" protective clothing has been designated as the appropriate protection for this project. The level of protective clothing will be upgraded if the organic vapor levels in the operator's breathing zone exceeds 5 ppm above background levels continuously for more than five minutes, or if any single reading exceeds 15 ppm. If this occurs then level C protection will be used. If the organic concentration in the operator's breathing zone exceeds 200 ppm for 5 minutes and/or the organic vapor concentration two feet above the excavation exceeds 1,000 ppm or 10% of the lower explosive limit, then the equipment will be shut down and the site evacuated. If organic vapor concentrations exceed 200 ppm and work continues then level B protection will be required.

"EPA Standard Operating Safety Guidelines" defines the levels of protective clothing as follows:

LEVEL A:

Fully encapsulating suit / SCBA / Hard hat / Steel toe boots / Safety gloves.

LEVEL B:

Splash resistant suit / SCBA / Hard Hat / Steel toe boots / Safety gloves.

LEVEL C:

Half face respirator / Hard hat / Safety glasses / Steel toe boots / Coveralls / Gloves.

LEVEL D:

Coveralls / Hard hat / Safety Glasses / Steel toe boots / Gloves.

If air purifying respirators are authorized, organic vapor w-filter is the appropriate canister for use with the involved substances and concentrations. A competent individual has determined that all criteria for using this type of respiratory protection have been met.

NO CHANGES TO THE SPECIFIED LEVELS OF PROTECTION SHALL BE MADE WITHOUT THE APPROVAL OF THE COMPANY SAFETY OFFICER, J.S. ANDERSON.

F. MONITORING INSTRUMENTS

The following environmental monitoring instruments shall be used on site at specified intervals.

Lower Explosive Limit (LEL) Meter that will also check the tank for Oxygen levels will be used to check the tank for removal and transportation.
