If the subject of the meeting is site investigation and cleanup, Alameda County Environmental Health is the lead agency. For topics related to the installation and operation of the UST systems, Livermore-Pleasanton Fire Department is the lead agency. It would be unusual to require both agencies at a meeting. Secondly, I have an extremely heavy caseload and must limit the number of meetings I attend and also limit my travel time. If the proposed meeting topics relate to site investigation and cleanup, I may be able to meet with you in the Alameda County Environmental Health offices in Alameda.
