On behalf of Aaron and Stanley Wong, Cambria Environmental Technology, Inc. (Cambria) requests an extension for submittal of the DPE System Start-Up Report. The original due date is November 15, 2006. We are requesting an extension to August 30, 2007.

Following is list of relevant issues with dates:

- July 7, 2006: Letter from ACEH with "November 15, 2006 DPE System Start-Up Report"
- August 22, 2006: Submitted a <u>Cost Pre-Approval Request for Remediation Design and Permitting</u> to Dave Charter with State Water Resource Control, Division of Financial Assistance, UST Cleanup Fund. No reply.
- October 6, 2006: Submitted e-mail to D. Charter requesting a status report on our preapproval request. No reply.
- November 8, 2006: Submitted e-mail to D. Charter requesting a status report on preapproval and stated that if we have not heard back from him by November 15, 2006 we will assume that we can proceed with the current phase of the remedial effort.

Assuming that we proceed in mid-November 2006 on the remediation system, with or without pre-approval, following is an anticipated schedule:

- January 30, 2007: Complete design and permitting for remediation system.
- April 30, 2007: Complete installation of remediation system (excluding PG&E hookup).
- June 30, 2007: Complete PG&E hookup.
- July 10, 2007: Remediation system start-up.
- July 30, 2007: End start-up phase and receive laboratory data.
- August 30, 2007: Submit DPE System Start-Up Report.

Two areas out of our control is the time required for the City of Oakland to review and approve the permit and PG&E to design and install the utility hookup.
