I spoke with Jeff Ludlow of Harding Lawson Assoc. regarding his response to the March 1, 1991 letter from this office which requested additional info and clarification. We discussed that, during our prior conversation a month to 6 weeks ago, we compromised on point #4 of the March 1 letter to the degree that it would be possible to collect and analyze only one sample from the proposed downgradient well, provided no "hits" are observed in the field during boring advancement. This single sample would be collected from the GW/ vadose zone interface.

I inquired about the response due March 31. He said that SFPUC said they had no funding to pay for the response, and did not give him the "go ahead" to respond. He feels the project will proceed to be implemented, but doesn't know when.

I then spoke to Larry James of SFPUC in Moccasin regarding the funding issue. He said the funding issue had just been solved, and that a response to the March 1 letter should be expected in the next couple of weeks.
