Jerry,

Given the complexity and rapid implementation of activities at this site recently, we are unable to provide the requested Monitoring Work Plan Addendum by June 25, 2008. After receipt of your letters dated June 10 and June 11, 2008, Shell requested that CRA re-evaluate the remediation of the site using the recently installed injection piping given the issues raised in your correspondence concerning monitoring activities in relation to the utility corridors and the BART tunnel. Based on this review, we will be proposing the installation of several additional groundwater monitoring wells (in addition to the two you requested) at this site to adequately monitor and evaluate the initial injection event.

The proposed additional monitoring wells will be included with the Work Plan for Vertical Delineation due July 15, 2008. The Work Plan Addendum, to include the pilot study for the ISCO activities and appropriate monitoring activities, needs an extension from June 25, 2008 to **July 31, 2008**. This will allow for the generation and appropriate internal reviews of the document prior to submittal to your office.
