It is approximately midway through the Public Notification period for the subject fuel leak case. To date, Alameda County Environmental Health (ACEH) has not received any comments from the public regarding the potential closure. At this time, ACEH requests that you schedule the well destruction activities for the subject fuel leak case. Please schedule the well destruction for at least two (2) weeks after the completion of the public notification and comment period. The public notification and comment period closes on December 20, 2014.

Please respond via email (Attention: Keith Nowell) confirming the date scheduled for well destruction by December 5, 2014.

ACEH will authorize the well destruction in a separate letter following the conclusion of the public notification period.
