Information from the former location of well C-15 would likely be useful; however, the consistency of the rose diagram flow direction indicates that a well downgradient of C-9 would fill a data gap in the perimeter of the well network. As mentioned in the second Technical Comment in the letter, C-15 appears lateral to the flowpath.
