Hi Jerry,

Here is the status of RO357 Snow Cleaners at the end of 8/1/08.

We successfully collected additional soil gas samples SG6 through SG11 this week, and they were received at the lab today 8/1/08. We also successfully collected all proposed surface water creek samples and all additional creek bank borehole water samples this week and those samples were also received at the lab today 8/1/08. The air samples will be analyzed on a normal (10 business day) turn around basis. We should have the results by the beginning of the week of 8/25/08. I will be out of town 8/21/08 through 8/26/08 and will provide you the air sample results upon my return to the office 8/27/08. We will need approximately two weeks to process the sample results prior to release of the report, resulting in a proposed revised report submittal date of September 8, 2008.

We have successfully completed drafts of geologic cross sections in the immediate vicinity of the site, and associated isoconcentration contour maps for the geologic cross sections and groundwater quality isoconcentration contour site vicinity maps for the area between Coolidge Avenue and 34th Street.

We still have not received our encroachment permit from the City of Oakland for installation of wells MW3 and MW4, and we have not been able to determine from the City when we will be able to get the encroachment permit. I spoke with the driller last week, and he said that he presently has about a two week lead time for scheduling. It is my hope that the wells will be installed, developed, surveyed and sampled prior to receipt of the air sample results. However, if further delays in obtaining the encroachment permit indicate that well installation will be delayed beyond the end of August, I will let you

know.
