Hi Jerry,

Groundwater extraction began at the site in the beginning of September 2012. However, flow rates were substantially less than 1 gpm because the water level dropped to near the bottom of the extraction well where the pump is located. We have requested that EBMUD extend the duration of the discharge permit to be year-round.

The BAAQMD permit has been delayed based on a lack of funds. We have now received a check for the BAAQMD permit fees and are waiting for the BAAQMD to complete review of the re-submitted permit application followed by their issuing an invoice so that we can send the permit application fees. The BAAQMD is now estimating approximately 60 days to process the permit application.

We last sampled the wells at Snow Cleaners in June 2012, and are presently scheduled to sample them in December 2012.

However, review of your 11/26/12 letter suggests that perhaps the next well sampling event should occur in the first quarter of 2013. Please let me know if the next well sampling event should be in December 2012 or in the first quarter of 2013. Thank you!
