P&D Environmental (P&D) has been retained by Mr. Harold Turner to address a request from your office for information regarding the subject site. This letter is written in response to Mr. Barney Chan's August 1, 2002 letter. In addition, P&D has been requested to address a November 4, 2002 letter from Ms. Shari Knieriem of the Underground Storage Tank Cleanup Fund (the UST Fund). It is P&D's understanding that you have been recently assigned as the new caseworker for this site.

As discussed with Mr. Chan on the telephone, Mr. Turner has advised P&D that he was hospitalized for the entire month of October 2002, and as a result has been delayed in responding to the request for information from your office. As discussed with Mr. Chan, this information was also provided to Ms. Knieriem during a telephone conversation. Ms. Knieriem advised that a letter be written to Mr. Chan and a copy of the letter be provided to her regarding the activities of P&D with respect to preparing a response for Mr. Chan's and Ms. Knieriem's letters.

P&D has made copies of the files available at your office, and will address Mr. Chan's request for information following review of the documents. P&D will also provide comments on the most recently submitted work plan for subsurface investigation prepared by others.
