## **Responsible Party Identification Background**

Alameda County Department of Environmental Health (ACDEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

# ATTACHMENT A - RESPONSIBLE PARTIES DATA SHEET (Continued)

### **Existence of Unauthorized Release**

A site assessment conducted in July, 1988 included the installation of four groundwater monitoring wells. Free phase product was observed in one of the wells. An environmental investigation conducted in 1989 revealed maximum concentrations of 11,000 milligrams per kilogram (mg/Kg) of total petroleum hydrocarbons as gasoline (TPH) and 40 mg/Kg benzene in soil; 9,500 micrograms per liter (ug/L) benzene in groundwater; and 6,100 ug/L TPHg and 10ug/L benzene in soil vapor. These concentrations indicate a release from the underground storage tank system has occurred.

#### Responsible Party Identification

Texaco Marketing and Refining owned and operated the underground storage tanks from March 31, 1966 to October 31, 1988. Chevron Corporation purchased all of Texaco and its assets. Chevron Corporation meets the definition of a responsible party for the site because it owned or operated an underground storage tank used for the storage of any hazardous substance (Definition 1), it had control over an underground storage tank at the time or following an unauthorized release of a hazardous substance (Definition 4), and it owned the property where an unauthorized release occurred (Definition 3).

Exxon acquired the property in October 1988 and was the property owner following an unauthorized petroleum hydrocarbon release(s). Exxon merged with Mobil in 1998, forming ExxonMobil. ExxonMobil meets the definition of a responsible party for the site because it owned the property where an unauthorized release occurred (Definition 3).

BNY Western Trust Company acquired the property in June 16, 2000 and was the property owner following an unauthorized petroleum hydrocarbon release(s). BNY Western Trust Company meets the definition of a responsible party for the site because it owned the property where an unauthorized release occurred (Definition 3).

Lam Truong purchased the property in June 1, 2001 and was the property owner following an unauthorized petroleum hydrocarbon release(s). Lam Truong meets the definition of a responsible party for the site because he owned the property where an unauthorized release occurred (Definition 3).
