On behalf of Buttner Properties, Fugro West, Inc., (Fugro) would like to thank you for your review and approval of the Work Plan for Additional Site Investigation dated January 16, 2009 for the property located at 2250 Telegraph Avenue, in Oakland, California (Site). As previously discussed with you, several logistical events need to occur to facilitate the investigation, including the tenant closing his business for one week.
