For future groundwater monitoring events we understand that the County is requesting Dissolved Oxygen analysis for all well samples. As recently discussed with you, Fugro has collected Dissolved Oxygen data using a portable field meter during most of our monitoring events. The data was presented on well sampling forms included with each monitoring report.

Since Dissolved Oxygen analysis samples have a very short hold time (15 min.) we understand collection of field data using a portable meter is acceptable. We understand that the County is requiring that this data be tabulated along with chemical data results and presented in future monitoring reports. Historic Dissolved Oxygen measurements for the past two years of monitoring events are also to be included in tabulated data sets.
