Dear Mr. Wickham,

As per our phone conversation today (5/31/2011), the deadline of the Semi-Annual Groundwater Monitoring Report - Second Quarter 2011 for the subject site has been changed from May 18th 2011 (as indicated in the March 17, 2011 directive letter) to July 18th, 2011. Mr. Lee Dooley, the former project manager for the subject site, stated that this had been discussed at the time the directive letter was issued.

A Semi-Annual Monitoring Report for the Third and Fourth Quarters of 2010 was submitted on January 31, 2011. The May 17th 2011 deadline is within the second quarter, which would not allow for site status and groundwater monitoring updates for the duration of the second quarter.

The Semi-Annual Groundwater Monitoring Report - Second Quarter 2011 will be submitted on or before the revised deadline of July 18th, 2011.
