Delta Environmental Consultants, Inc. (Delta), on behalf of Shell Oil Products US (Shell), has prepared the following Request for Permit Extension for the above referenced site.

Request for Permit Extension

The groundwater treatment system at this site was shut down on May 4, 2006 and monthly discharge reports have been required to maintain the discharge permit. A review of recent trends of fuel hydrocarbon related constituents indicate it is unlikely the remediation system will need to be activated again. It is therefore our intent to remove the remediation system and cancel the permit. You have informed us that the permit will be coming up for renewal soon and you would need to know our intentions in early September if we would need to have a permit renewal or extension.

We are currently in the process of discussing and coordinating the system removal with various subcontractors and it is clear we will not have the system removal completed by the end of September. Since we do not have a removal date at this time we request a permit extension of two months. We will contact you regarding the removal date so you can schedule an inspection and the permit cancellation process can be started. We will continue to submit monthly discharge reports until we are informed in writing of the permit cancellation. If we will need more than a two month extension we will contact you as soon as that becomes apparent.

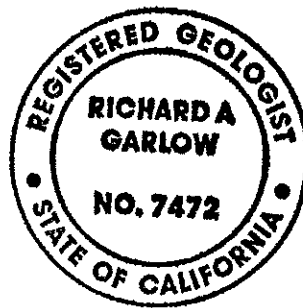
