The case closure applies to the reported releases from the UST system at the former service station. The Case Closure Summary identifies the site as former parcel 413-3-1-5. Site investigation activities to define the extent of contamination did not extend into the small adjacent parcel in the corner. The key factor seems to be that there was no apparent need to expand site investigation and cleanup beyond the parcel boundaries. Since there was no apparent need to expand the site investigation and cleanup beyond former parcel 413-3-1-5, I would say the closure applies to the reported releases from the UST system in former parcel 413-3-1-5. Hope this answers your question.

Do you have time for one last (hopefully) question about this closure report? If so, here it is:

The former gas station covered the entire corner of Lewelling and Hesperian. If you look closely at the parcel map, you will see that the actual corner, a parcel of about 3500 sq.ft. is a separate parcel number which belongs to the city and not to us. All the maps showing remediation seem to include that corner parcel so I am assuming that the closure report covers that small section as well as the larger section.. It is too long a story to tell, but it is possible that this small portion of the corner will become part of our site. Are we free to assume that because the larger parcel was remediated and cleared that this would apply to that small corner as well? I have attached a photo of

the corner to make it easier to see what I am talking about.
