

Dianne Lundquist (Cambria) called today to let me know the SV extraction /treatment system was now in operation at the site.



I spoke w/ Rick Waxman (atty for Big-O) for a few minutes regarding status of negotiations w/ Shell and property owners (Salal) with respect to corrective action at the site. Apparently, parties are still negotiating. I'll wait to see what comes of all this before approving any CAP.

I left a message for John Redding (atty for prop owner) on 11/21/97 in response to his prior call inquiring about the status of CAP. I informed him as I did Mr. Waxman: I'm awaiting feedback from the involved parties. When Redding and I last spoke in August, he said he's not so sure his clients would be satisfied with a SUE system at the site, both in terms of the ^{loss of} space from the treatment compound, and because it was not necessarily as "final" a remediation technique as excavation and soil disposal.

I spoke yesterday with Diana Landquist (Envirocs), and covered the same topic with the same response.

Rick Waxman (atty for Big-O) spoke to me today regarding his perspective on scheduling the corrective action at the site in the wake of the recent supplemental investigation and looming approach of the Labor Day weekend, the "do-or-die" date for Big-O to be in business @ the site. He mentioned, as I already knew, that J. Redding (atty for prop owner) was out of the office this week which prevented him from discussing current issues with Redding.

Waxman indicated Big-O may now be looking @ a Spring '98 opening. This, I informed him, may change the corrective action approach (i.e., excavation vs. SUE) with this additional time. Shell and the other parties need to finalize their negotiations.

I told him the areas of interest appear to be the former station building and both dispensing ~~islands~~ islands. The northern part of the site appears to pose no theoretical risk.

I will await word from the involved parties before moving forward with approval of the (AP).
