James,

Per your email below dated 9/22/17, we are notifying the ACPWA that drilling/sampling work pertaining to Permit No. W2017-0755 was not completed on 10/14/17. Pertinent to the importance of our investigation, no groundwater was measured in 5 of the 6 permitted boreholes. Only groundwater entered B39 (West parking lane of College Avenue), and was subsequently sampled prior to its backfilling by tremie grout. B40, also located in the west parking lane of College Avenue, was backfilled to grade surface (See attached photographs).

Previous investigation activities have shown that groundwater entered GeoProbe boreholes at the site following approximately 4 to 5 days following drilling completion. In current borings B36, B37, B38 and B41 (See attached revised Site Plan), piezometer casing was installed to the total depth of each borehole, and secured at grade, then sealed with hydrated granular bentonite and a thin concrete surface cap to inhibit surface water infiltration. Wheeler Group is tentatively scheduled to revisit the Site on Thursday, 10/19/17 to collect grab groundwater samples in remaining boreholes and backfill to grade surface. We will contact ACPWA inspector 72-hours in advance of confirmed sampling/backfilling.

Drilling and soil vapor well installation was completed per Permit No. W2017-0756 (See Photographs).

Prior to completing online drilling permit application through ACPWA for proposed drilling/sampling activities at subject property, Wheeler Group Environmental LLC requests that drilling occur on a Saturday (tentatively scheduled for 10/14/17) for the following reasons:
