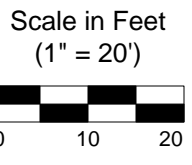
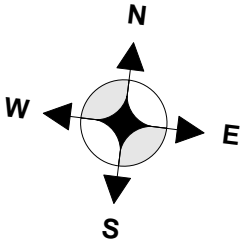
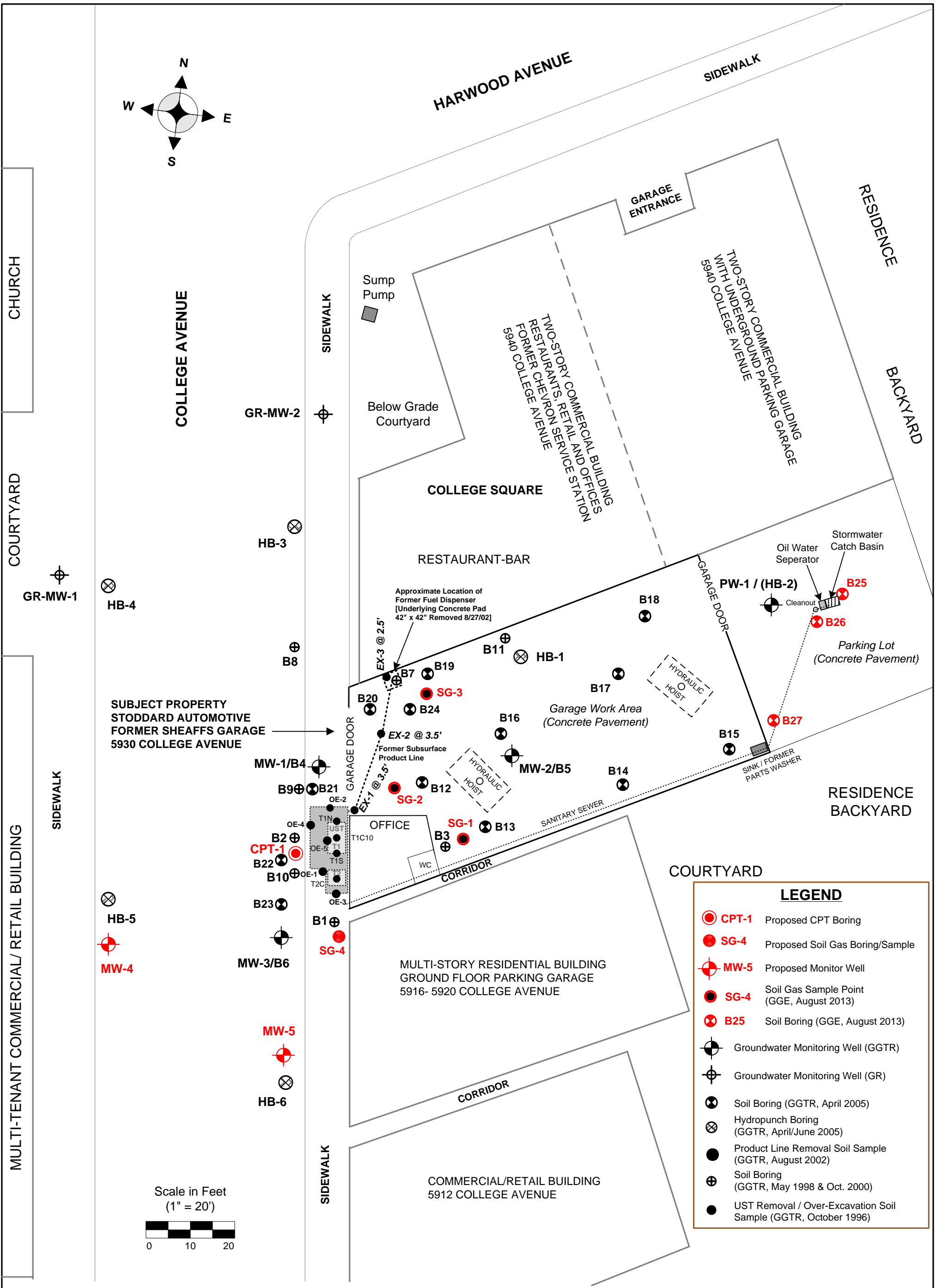
Golden Gate Environmental, Inc. and TEG Northern California (Mobile Lab) will be conducting Step Purge Volume Testing and Soil Gas Sampling activities at the subject Site on Monday, August 26, 2013. Field work will begin at approximately 7:30AM.

In addition to Borings B25-B27, Soil Gas Probes SG-1, SG-2 and SG-3 were drilled/installed at the Site on August 8, 2013. The actual locations of each boring/probe are shown on the attached Site Plan (revised 8/19/13). Soil Gas Probe SG-4, as well as the other proposed borings/wells, will be installed at the Site upon approval of pending City encroachment permit.

Soil gas sampling activities will be performed in general accordance with the October 29, 2010 Work Plan Addendum for Soil Gas Sampling prepared by Golden Tank Removal, Inc. Please contact us with any questions.
