Dear Larry:

It appears we have located an offsite source for the gasoline-related contamination found: (1) under our property at 2855 Mandela Parkway, Oakland, next to Willow Street, and (2) under Willow Street.

CERES Associates sent you its November 18, 1998 Additional Subsurface Investigation Report for 2853-2863 Mandela Parkway in Oakland, California (the "Additional Investigation"). We performed the Additional Investigation to determine if the contamination might be from 2 underground storage tanks (1-gasoline, 1-waste oil) removed from our property in 1991.

The Additional Investigation results indicate the likely contamination source is offsite, specifically an abandoned gasoline underground storage tank (the "Tank") located directly across Willow Street from our property at 2607 Mandela Parkway. This Tank was abandoned in place in February 1997.

We believe the Tank is the source of the contamination for four reasons:

- 1. The contamination is down gradient from the Tank.
- 2. At the time of abandonment, the consulting report showed the Tank contained gasoline, and was "rusty, pitted, [and had] several holes." (Light, Air & Space Construction, Underground Tank Technical Closure Report, 2/20/97.)
- 3. The contamination is up gradient from the 2 tanks removed from our property.
- 4. We could not find a tank near the contamination. In the Additional Investigation, CERES Associates surveyed our property and Willow Street around the contamination with (a) ground penetrating radar, (b) a hand-held magnetic locator, (c) split box inductive locator and metal detector, (d) magnetometer, and (e) 9 probe holes, and could not find a tank.


