The bottom line is that the RP has very limited resources to do more corrective action and has not been able to get reimbursement from the cleanup fund, even for routine monitoring. Mr. Chun has said that he would just have to go into his retirement fund to do the cleanup and hope to get reimbursed later. I would like to propose that we spend what little money there is available to do as much cleanup as possible before we do more investigation and re-conditioning of wells, etc. I would simply like to use Cal Clean to do dual phase extraction with air sparging as past RAPs have shown that this will be effective. Let me know if this is amenable to you.
