Mark and Dilan,

Conestoga-Rovers and Associates (CRA) on behalf of Chevron Environmental Management Company (EMC) would like to request an extension for the Soil and Groundwater Investigation and Path to Closure report submittal date that was requested by Alameda County Environmental Health (ACEH) in an email dated July 12, 2013. This extension request was discussed in a meeting with ACEH, EMC and CRA at ACEH's building on September 12, 2013, this email is to follow up on that conversation. There are other Chevron sites within ACEH jurisdiction that have a higher priority for the field work to be completed this year and would like to concentrate on those activities. The field assessment proposed in CRA's *Site Conceptual Model and Work Plan for Additional Subsurface Investigation* dated August 31, 2012 (approved by a ACEH letter dated July 12, 2013) is not to determine health risks but to confirm site remediation and off site hydrocarbon delineation. CRA's *Site Conceptual Model and Work Plan for Additional Subsurface Investigation* contained the sampling results, from the vapor probes that are located on the down gradient site property boundary, indicated that there is not an offsite vapor intrusion risk. Due to the need to conduct activities on the higher priority sites and the lack of risk at this site, it is requested that the approved field activities be conducted in early 2014. A driller can not be scheduled at this time because the drillers do not schedule that far in advance. ACEH will be notified once the field activities are scheduled and a report documenting the field activities will be submitted 60 days after the laboratory results have been received.

The scheduling for the offsite domestic well destruction will be conducted independently of the activities mentioned above. ACEH will be notified once the well destruction is scheduled.

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.
