WORK PERFORMED THIS QUARTER (Third Quarter 2010):

1. Prepared and submitted the *Second Quarter 2010 Status Report* (BAI, 7/6/2010).
2. No environmental field work was performed at the Site during the Third Quarter of 2010.

WORK PROPOSED FOR NEXT QUARTER (Fourth Quarter 2010):

1. Prepared and submitted this *Third Quarter 2010 Status Report* (contained herein).
2. No environmental field work is scheduled at the Site during the Fourth Quarter of 2010.

DISCUSSION:

In a letter dated 17 September 2008 from the Alameda County Environmental Health (ACEH), Mr. Paresh Khatri stated that as concentrations of contaminants in ground water appeared low and concentrations of contaminants in the confirmation soil samples were not detected above the laboratory detection limits, the Site appeared to qualify for case closure evaluation. As stated in a letter dated 7 January 2010, the ACEH and California Regional Water Quality Control Board reviewed the fuel leak case and case closure summary for the Site and concurred that no further action related to the underground storage tank fuel release was required. However, prior to issuance of a remedial action completion certificate, the monitoring wells at the Site had to be properly decommissioned and a List of Landowners Form submitted. On 15 January 2010, the completed List of Landowners Form was submitted to ACEH and GeoTracker listing the following individuals as owners of the property: Nooshin Salkhi, Ali Salkhi, Arash Salkhi, Banassheh Salkhi, Amin Salkhi, Souri Salkhi, and Ajang Salkhi, in care of Amin Salkhi at 605 Contra Costa Boulevard in Concord, California 94523.

On April 13-15 2010, BAI observed Cascade Drilling (a C-57 licensed drilling contractor) decommission the former monitoring wells associated with the Site. On 28 May 2010, BAI submitted the requested *Monitoring Well Decommissioning Report* to the ACEH. On June 28-29 2010, BAI observed Cornerstone Environmental (a Class A General Contractor) replace the three damaged sidewalk panels at former well locations MW-7, MW-9, and MW-10, as required by the City of Oakland. BAI has completed the work requested by ACEH as necessary to obtain the remedial action completion certificate stating that no further action is required. BAI and BP are eagerly awaiting the receipt from ACEH of the 'no further action'/remedial action completion certificate. As a reminder, a Site Location Map is provided as Drawing 1. A former Site Layout Plan is presented as Drawing 2.

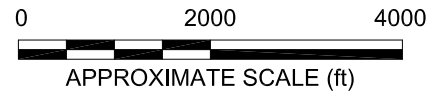
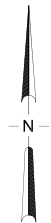
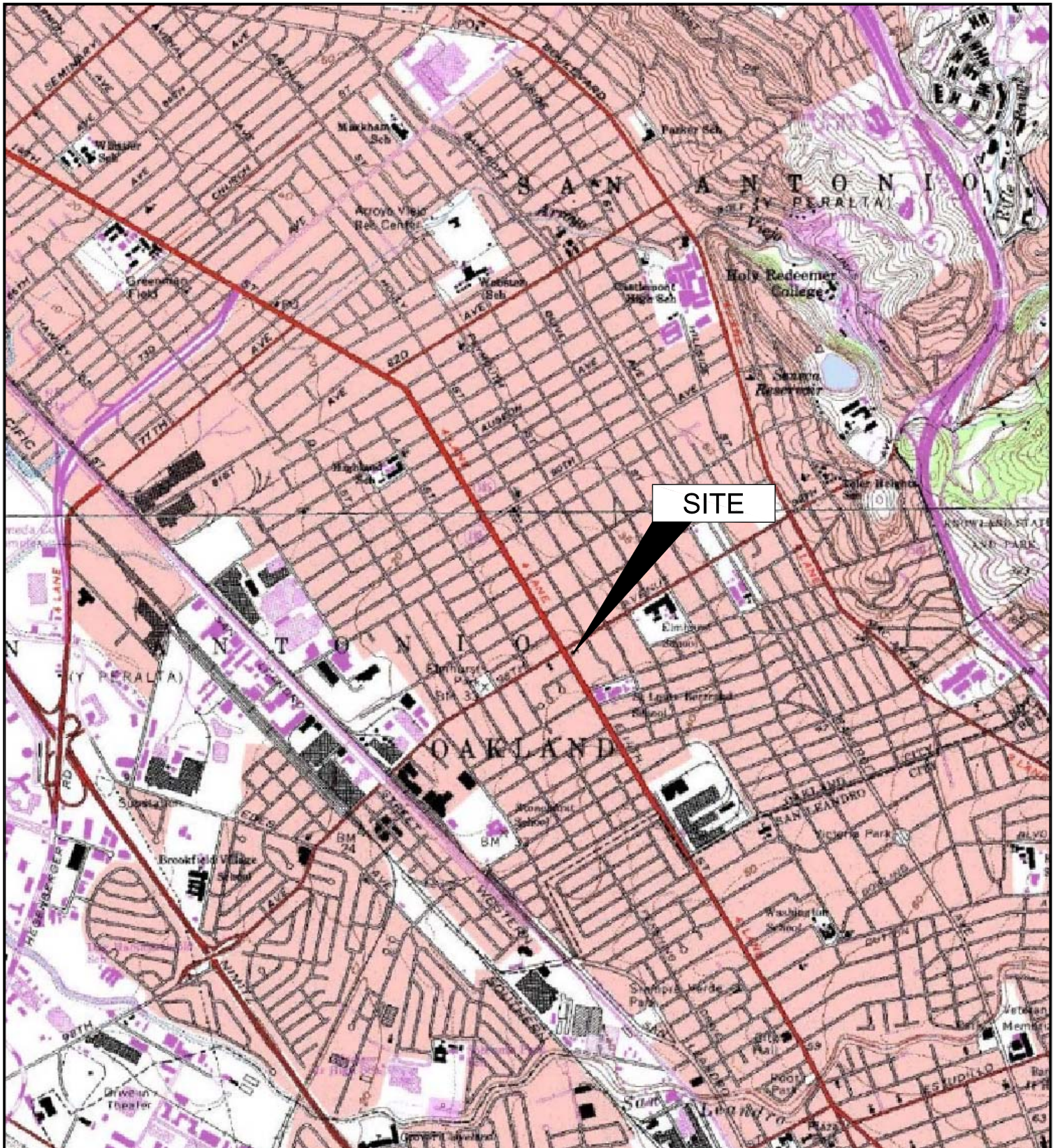

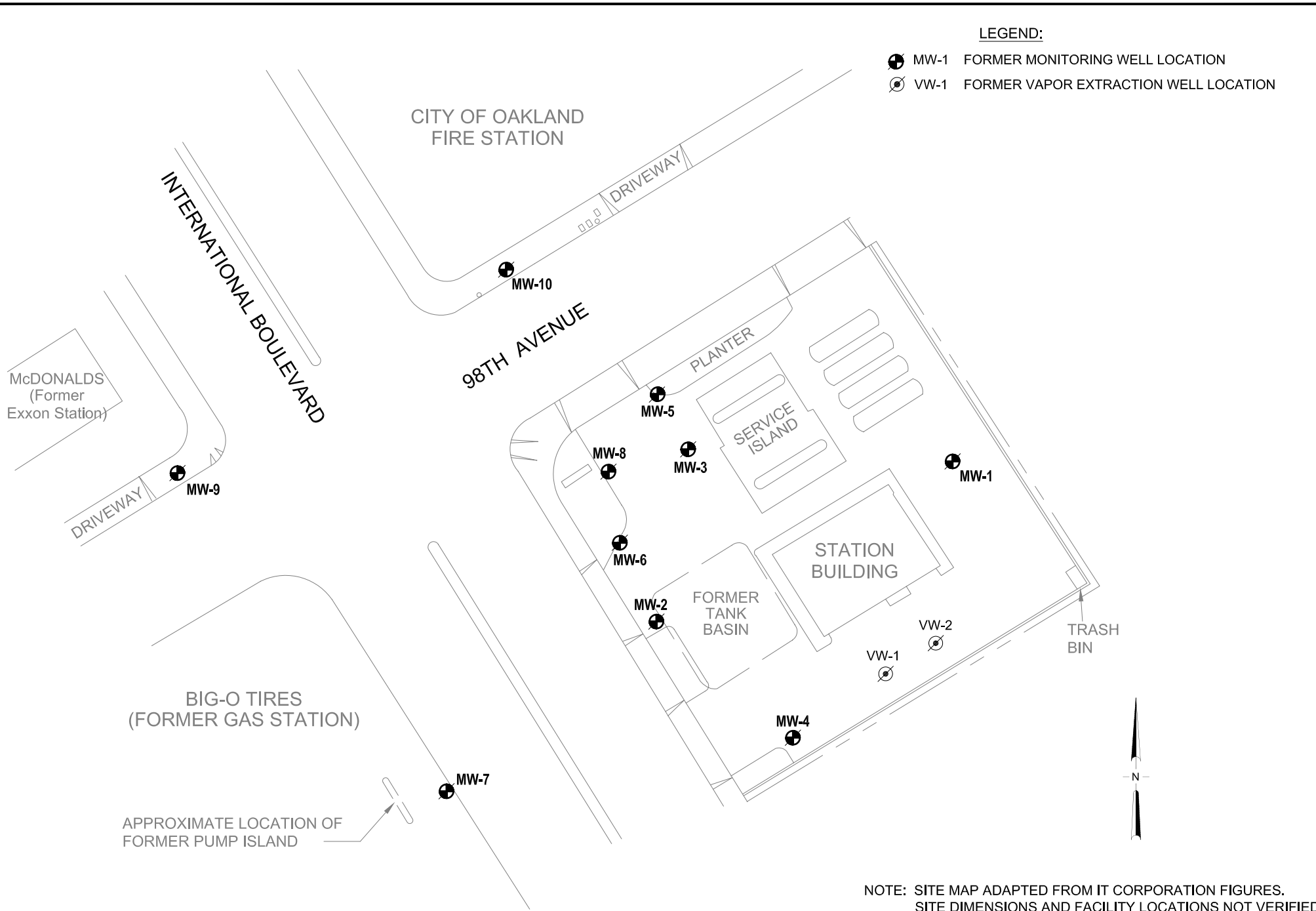
