The recent ACEH directives for site R)403 and RO14 indicate we need to have our pilot tests done by late September and a report in by late October. We are lined up to mobilize into the field with the driller for both sites until the week of 9/7 with development on 9/13. We'll start the pilot test the following week and could be running it for 60 days (depending how the aquifers react). This could put us into late November. Any way we could have an extension for report submittal to by January 7, 2011?
