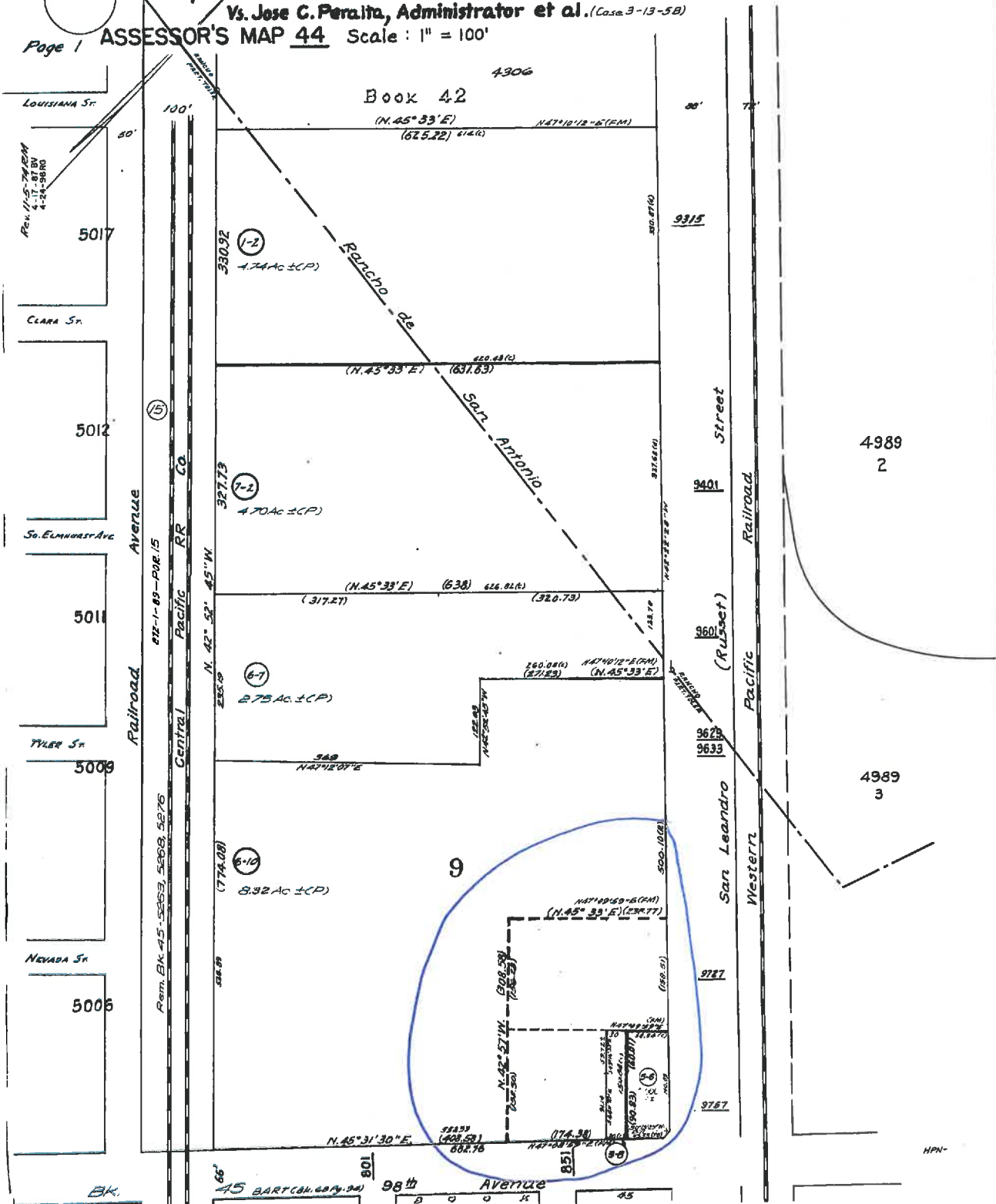
PLAT OF THE PART OF THE RANCHO DE SAN ANTONIO Code Area No. 17-032
