

WORK PERFORMED THIS QUARTER (Second 2011):

1. In accordance with SWRCB Resolution No. 2009-0042, no groundwater monitoring or sampling was conducted at the site during second guarter 2011.

WORK PROPOSED FOR NEXT QUARTER (Third 2011):

- 1. Stratus will conduct groundwater monitoring and sampling activities third quarter 2011. During this event, wells MW-1 through MW-9 will be gauged to determine depth to groundwater, evaluated for the presence of free product, dissolved oxygen (DO), temperature, pH, oxygen reduction potential (ORP) and conductivity. Following gauging, these wells will be purged and sampled. Groundwater samples will be forwarded to a state-certified analytical laboratory for analysis.
- 2. Stratus and the Responsible Party met with ACEHD personnel on July 28, 2011 to discuss the project and upcoming work activities. ACEHD requested that interim remedial action be performed at well MW-1 to manually remove free phase liquid hydrocarbons (free product from well MW-1). Beginning in August 2011, Stratus will begin monitoring free product thicknesses, and manually removing free product mixture, on an approximate weekly schedule.
- 3. On November 16, 2010, Stratus prepared and submitted a document for ACEHD review that included a revised proposal to conduct subsurface site investigative activities in order to further evaluate the lateral and vertical extent of petroleum hydrocarbon impact to soil, groundwater and shallow soil gas. During the July 28, 2011 meeting, goals of the site investigation were discussed and it was agreed that revisions to the proposed work scope were appropriate. Based upon the discussions on July 28, 2011, Stratus will submit a revised *Work Plan* to complete a subsurface investigation in August 2011.
