Dear Messrs. Herman and Tisoncik:

The above-referenced site is a *Site Cleanup Program (SCP)*, formerly the Spills, Leaks, Investigations, and Cleanup (SLIC) program, case due to the presence of soil and groundwater contamination on the property. Alameda County Environmental Health (ACEH) is the agency providing regulatory oversight for this case. In order for ACEH to complete the regulatory review and closure process, we require a deposit to an oversight account.

As requested during the meeting on October 22, 2013, ACEH has determined that the current outstanding deficit for work to date is \$4,950.20. In order to facilitate case closure evaluation, please send a check in the amount of \$10,000.00 payable to Alameda County Environmental Health. Please send your check to the attention of our Finance Department.

This additional deposit may or may not be sufficient to provide all necessary regulatory oversight. ACEH will deduct actual costs incurred based upon the hourly rate specified below. If these funds are insufficient, additional deposit will be requested. Otherwise, any unused monies will be refunded to you or your designee.

The deposit is authorized in Section 6.92.040L of the Alameda County Ordinance Code. Work on this project is being debited at the Ordinance specified rate, currently \$204.00 per hour.
