Subject: 04FGN: Waste-Oil Tank Sampling

Barbara Jakub,

I am sending this correspondence to transmit information pertaining to the waste-oil tank sampling for former Mobil Station 04FGN located at 14994 East 14th Street in San Leandro. This information was requested by your agency in a letter dated 20 August 2008. In the letter, you had indicated that your case files do not contain reports of analysis pertaining to the former waste-oil tank at the site and you requested any reports documenting analysis by 30 September 2008. Your letter indicated that if sample results are not available, that a work plan should be prepared to investigate the waste-oil tank area.

Available information in our files regarding the waste-oil tank was already submitted in previous reports for the site. However, additional efforts were made to obtain the requested information. A city or county fire department will typically oversee the removal of an underground storage tank (UST) and they may retain information on such removals.

As indicated in our correspondence dated 19 September, 2008, ETIC conducted a file review at the City of San Leandro on 24 September 2008. Information was discovered in the file which relates to the former waste-oil tank. According to that information, a 300-gallon waste-oil tank was removed from the site in December 1986 along with the three 6,000-gallon gasoline USTs. Analytical results of a soil sample ("Waste-Oil") show concentrations of <1 mg/kg Volatile Hydrocarbons and <0.1 Extractable Hydrocarbons. A map along with the analytical results shows the proper location of the former waste-oil tank. This information is attached to this correspondence. Other information related to the site but not specifically related to the waste-oil tank was also obtained but not attached.

The information and analytical methods regarding the waste-oil tank obtained from the City of San Leandro is typical of those at the time the tank was removed and they demonstrate the lack of a release at the waste-oil tank. Based on this information, no further action including investigations related to the waste-oil tank is requested.

Please let me know if you have any questions or if you would like us to submit all of the documents obtained from the City of San Leandro. Thank you.
