Hello Karel,

Arcadis received your October 8, 2018 letter. Thank you for reviewing Arcadis' modifications to the proposed boring locations presented in the *Supplemental Site Evaluation Work Plan* due to constraints imposed by the City of Oakland. We submitted another request for access to the owner of 4246 Foothill Blvd (location of soil vapor probe SV-02)

pursuant to Jamey Peterson's October 2, 2018 email to you. I am happy to report that we now have a signed access agreement in place with the property owner to install a probe on that that property.

We have received the encroachment permit from the City of Oakland and have secured the soil boring permits from Alameda County. At this time, we have utility locating planned with a private utility locator for November 27, 2018. The drilling activities are planned for December 3 through 5, 2018. Please consider this correspondence as our 72-hour advanced written notification to your office of the planned field activities.

After the completion of the soil vapor probes, we will need to complete a soil vapor sampling event. This is tentatively scheduled for mid-December. Assuming all data are received by the end of December, Arcadis respectfully requests an extension to the technical report deadlines presented in your October 8, 2018 letter. We would like to request an extension of the *Soil, Soil Vapor, and Groundwater Investigation Report* from December 10, 2018 to **February 15, 2019**. We would also like to request an extension of the *Draft Corrective Action Plan Addendum and Updated CSM* from December 21, 2018 to **March 1, 2019**. Please feel free to contact me if you have any questions or concerns that you would like to discuss further.
