Thank you for the verbal notification today that no public comments were received for the CAP/Test Workplan for 1230 14th Street, and that testing can proceed. As you requested, here is our tentative schedule for pilot testing and CAP implementation for you to reference for your regulatory directive letter.

Test well installation by July 15, 2008  
Conduct pilot testing by August 1, 2008  
Submit pilot test report by September 1, 2008  
Complete system design by October 1, 2008  
Install system by November 15, 2008  
Report on system performance within quarterly monitoring reports, starting with the "Groundwater Monitoring and Remediation Report - Fourth Quarter 2008" by January 31, 2009.
