Here are the summary's for County Cases RO#35, the Trailer-on-Flat-Car Site or TOFC, and RO#435, the Union Pacific Motor Freight Site. Both files are a mixture of projects including UPMF, UPMF & TOFC, TOFC, and the Port's Vision 2000 Program that relates to the UPMF and the TOFC. The Vision 2000 Program or V2K was conducted under Order 99-055 prepared by the local Regional Water Quality Control Board. The County was informed about the design and construction of a groundwater and free product diesel treatment system that addressed the TOFC with capability (at the time) of expansion of the system to address the UPMF area. The TOFC file, RO#35, contains reports and correspondence about a spill of diesel fuel that occurred on the rail tracks east of the TOFC located in front of the former APL Terminal administration building. A fuel tank on a Union Pacific locomotive was punctured by a broken steel rail. Union Pacific performed a removal action removing several gondola railcars of ballast rock and underlying soils.
