Dear Mses. Treinen and Pingston, and Mr. Kaczmarek:

As you are aware, the public comment period for the subject site ended on October 13, 2014. No comments were received by Alameda County Environmental Health (ACEH).

Except for wells MW-5 and MW-7, which are being used with your knowledge to investigate the two immediately adjacent sites north of the subject site, you are free to proceed with the destruction of wells associated with the site (groundwater, vapor, etc), as requested in the attached August 6, 2014 letter from ACEH. You may wish to reach an agreement regarding future use of wells MW-5 and MW-7 with the adjacent property owners.

- **4 Weeks After Completion of All Required Submittal Tasks** Uniform Closure Letter Issued (Provided no public comments of substance have been submitted)

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.
