Good Morning – I have taken over for David Herzog as the CRA PM for Brian Waite's Chevron sites, including many in Alameda County. We currently have six sites in Alameda County for which we which have received case closure letters requesting well destruction reports by the end of this month. The sites are listed below, along with their current status-

I am asking to have the deadline for the submittal of our well destruction reports extended to mid-November, to allow time to complete the work and get the waste offsite prior to submitting our reports.
