I spoke with Debbie Perez today. She apparently owns this site. Pettiti assumed her loan and is in the process of paying for the property and its improvements. She said that she bought the property in a partnership, holding it just a year, before selling to Pettiti, Sr. A very large balance is still owed on the property. Anthony Pettiti has apparently informed Ms. Perez that he cannot continue making payments - he flatly has no money.

She indicated that her partnership purchased the site from the De la Rosas (?). The De la Rosas apparently purchased the site from Texaco. Ms. Perez indicated that an environmental report was written in 1972 following some sort of investigation. She said the report indicates contamination was at the site at that time. She indicates that this info was not made available to her when she purchased the property, nor was it made available to Pettiti. Its mere existence, she indicated, was just recently brought to her attention.

I spoke with Steve Kennedy today (444-5500), attorney for the estate of John G. Pettiti. He said that the estate is cash poor right now. He said they are attempting to secure a \$75K loan on the Pettiti home right now so that the required additional (and continued ongoing) work may proceed. He said Anthony Pettiti, executor of the estate and son of the deceased, is pretty upset about the money being spent on this property. Mr. Kennedy understands the requirement to continue the investigation. Mr. Kennedy said that the SWRCB rejected an application ~~for~~ for SB 2004 funds because the USTs were never registered / permitted. Mr. Kennedy and I discussed that the UST laws were effect since 1984. UST owners were compelled by this statute to at least register the USTs, I told him. The county then began their UST program sometime in 1987, requiring a permit to operate the tanks. I informed Mr. Kennedy that it is the responsibility of the UST owner/operator to know and comply with the laws that regulate USTs. ~~Mr. _____ said~~
This statement I made when Mr. Kennedy said ~~no~~ no mention was made on the ^{early} ADGETT inspection report(s) that USTs were required to be permitted; he admitted, however, that my inspection in 1989 indicated so, among other elements of compliance (e.g., Hmmp, etc.)

Mr. Kennedy said a letter was forthcoming from his office explaining the current status of the financial and environmental aspects of this site.

I spoke to Misty Kaltreider of ACC today. She said that ACC has not performed any other work at the site since the wells were last sampled in February 1992. ACC had submitted a bid package to Petitti for the additional well installations. She said there has not been any contact since.

I spoke with Don Burnett of Phillips 66 Petroleum today (916-661-~~3865~~). His company markets two racing fuels (B-32, -36) apparently distributed by "TRICK" racing fuels, supplier to Anthony's Auto Service. MSDSs for these two fuels were included in the 3/92 ACC report, following our request for MSDS for the products sold at this site. Phillips' MSDS have a trade secret provision that precludes them from listing the compounds in ~~these~~ their fuels. I FAXed a list of chemicals (5) found in GW to date. He said he would respond.

I spoke w/ John Mrakovich (Tank Protect Org.) today regarding future sampling. After some discussion, I told him that we need monthly GW level measurements for the 1st year; quarterly sampling; TPH-E / BETX analysis quarterly. He wanted to limit the analyses to iso-Octane only, as this was what he considered the only substance identified in G.W. samples. The lab report indicates that, although 160 and 120 ppb of TPH-G were found in well-1 and -3, respectively, the samples do not appear to contain gasoline. I told Mr. Mrakovich that racing fuel was stored in the tanks most recently; perhaps iso-Octane, a common fuel additive, was in higher % than typical fuel.

I spoke again today with John Mrakovich. He said that his clients may not accept his telling them about monthly GW levels unless they receive a letter to that effect. I said that such a letter will follow once an in-depth review of the data is completed.

The report indicated that wells had not yet been constructed; only overexcavation of the tank pit and aeration/treatment of the exhumed soil had occurred during the reporting period (4th qtr. 1990). ~~the~~

He indicated, however, that wells were installed last Thursday & Friday (~~Jan 31~~ Jan 31 & Feb 1), although they have not yet been developed or sampled. He said TPE will issue an "interim" report regarding the wells shortly after water analyses results are available.
