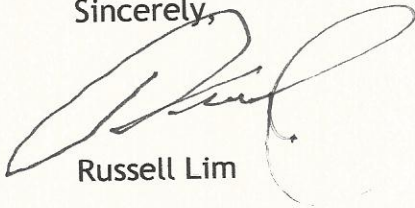

Dear Ms. Soo:

Per your request, attached is an updated site plan for the Lim Family Property located at 250 8th Street in Oakland, California. This site plan better shows the historic UST and excavation locations, as well as previous borings and the five proposed soil vapor locations, than our previous site plan.

ASE also visited the site to evaluate whether properties downgradient of the site had basements, subgrade elevator shafts, or crawlspaces. ASE inspected the off-site properties to the best of our abilities considering access limitations and asked on-site tenants or property owners questions regarding the existence of basements, elevator shafts or crawlspaces.

None of the buildings south (downgradient) of the site had basements. None of the buildings had crawlspaces, as far as could be seen. The building address 259 8th Street had an elevator, but ASE was told that the elevator shaft did not extend to the subsurface. ASE also checked the neighboring Chinese Independent Baptist Church at 280 8th Street, crossgradient of the site. This site also didn't have a basement or elevator. We were told that the building behind this address on 9th Street, which is also part of the church, had an elevator. However, this elevator is upgradient and not immediately adjacent to the site.

All of the buildings are shown on the attached map.

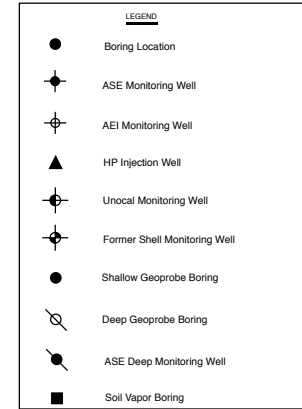
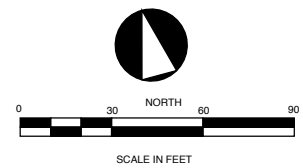
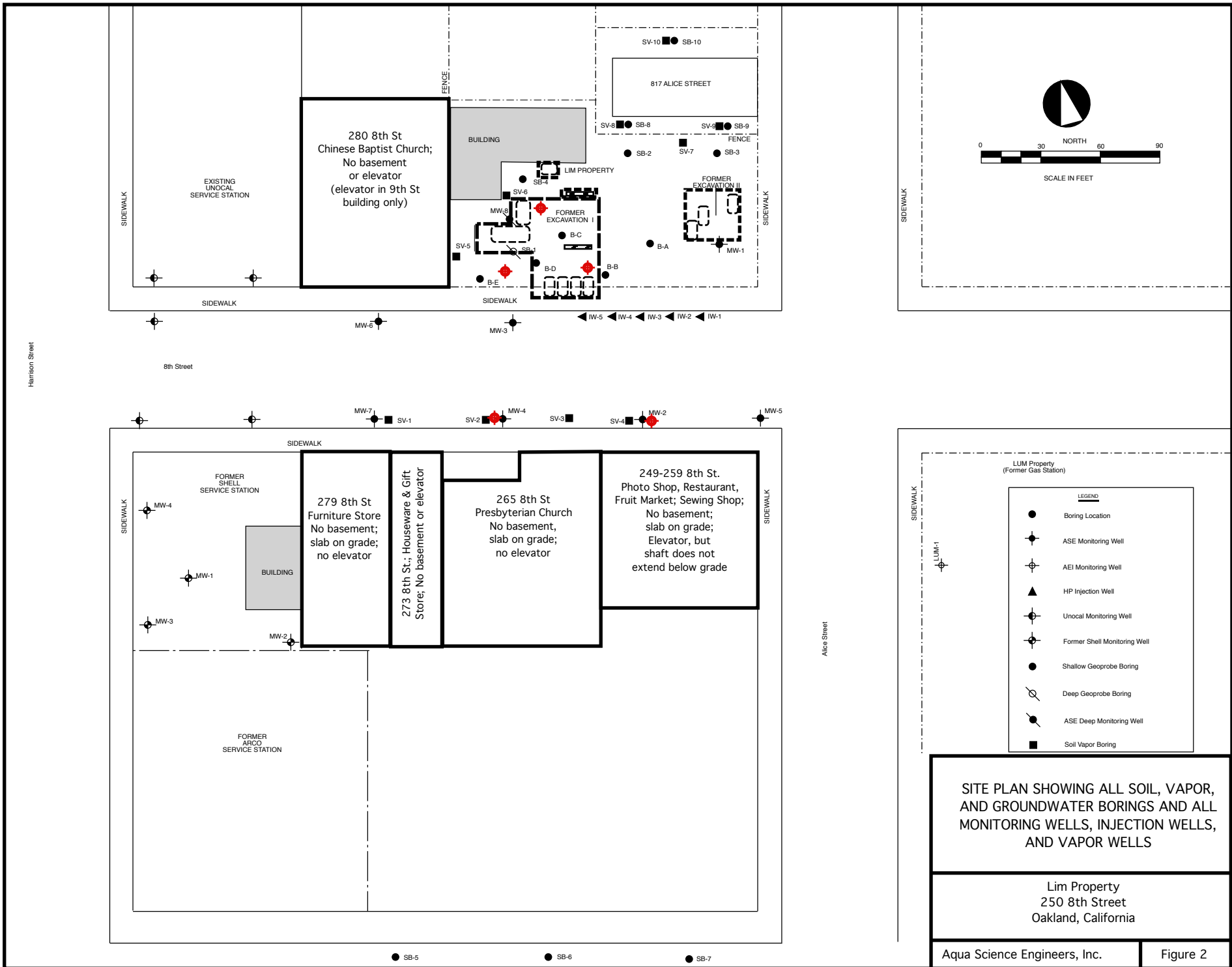
