JE made aware of written complaint from church, 12/7/92 addressed to Rafat, dated 11/30/92. JE spoke w/Craig Hertz of All Environmental, the current consultant. said the RP also got a copy of the 11/30 letter. church has wanted to buy the adjacent Lim site for a long time, but Lim doesn't want to sell. The church wall facing the Lim site has no windows or doors. thinks the other side of the church is adjacent to (or just a few doors away) a Unocal station (800 Harrison St., STID 918). This Unocal installed 3 more wells on 10/1/92 to define extent of gw plume (gasoline). under one dispenser has 1,200 ppm TPH-g; it was not removed because the canopy would probably collapse. Anyway, C. Hertz began over-excavation on 12/1/92 (after the 11/30 complaint). On that day, they used a TraceTechter instrument to monitor total hydrocarbons in Their highest reading was 20 ppm, in the vicinity of the large pit adjacent to 8th St., where the highest levels of gasoline were originally detected. They also monitored air levels near the church door, and found Since then, they proceeded over-excavating on 12/4/92. The rains have hampered the project since.
