### UST Cleanup Fund Recommendation (UPDATED, May 2010)

The site investigation has been underway for 22 years and no active remediation has been conducted in 14 years. By letter on 29 April 2010, the Alameda County LOP directed the Responsible Party to assess preferential pathways, conduct a soil vapor survey, and assess the potential for vapor migration. The Fund concurs that this work is appropriate to determine if the site is ready for closure. The fund will review the sit next year to track progress.

### ACEH Response

ACEH is in general agreement with your updated recommendations. An e-mail dated May 5, 2010 from the Responsible Party states that their environmental consultant will submit the requested documents (i.e. work plan) by June 22, 2010. ACEH will expedite the review upon receipt of the work plan and progress the case towards closure evaluation.
