06/23/99 David Elias called to say that they've contracted Sustainable Contracting Services to install the Soil Vapor Extraction System. He will keep me posted.

08/30/99 David Elias called to say that the Soil Vapor Extraction System will be installed. Started process. Got permit. Should have it done in about 2 months.

- 05/03/99 Called Owen Ratchye, Cambria, (510)420-3316, & left message requesting that he submit schedule of work for installation of extraction system, as agreed upon in a 04/15/99 conversation. Requested that he call me to give me update on schedule or fax me schedule.
- 05/03/99 David Elias, Cambria, called to say that his taking over the case from Owen Ratchye & that he has to get up to speed on case before getting back to me w/ schedule. He requested that I call him at (510)420-3307.
- 05/04/99 Called David Elias and left him message requesting he return my call & have anticipated schedule for installation of SVE on my voice mail.
- 05/04/99 David Elias called. Discussed work at site. SVE should be installed by mid- to late-June & will call me at least a week in advance of work.
- 05/21/99 David Elias, Cambria, (510)420-3307, called to update me on SVE installation schedule. The contractors initially slated for the SVE installation can no longer do the work, so there will be some delay because he needs to reassemble a team.

- 02/17/99 Naomi English, property owner, (510) 483-9015, called to acknowledge receiving letter from County, dated 01/12/99. She stated that Cambria consultants are handling her case & to work w/ them.
- 03/01/99 Called & left message for Owen Patchye, Cambria, requesting that he call me w/ status of BVE implementation.
- 04/05/99 Contacted Owen Patchye, Cambria, (510) 420-3316. Inquired about whether they obtained permit from BAAQMD for the soil vapor extraction system. He stated that they did. I requested that Mr. Patchye write the County a letter providing us w/ a Schedule of Work for when extraction system will be installed & when a report will be submitted documenting the work.
- 04/06/99 Contacted Owen Patchye, Cambria. Although the County sent him a letter on March 02, '99 requesting that Cambria's future Quarterly R.W. Reports include all a summary of all historical sample results, their First Qtr '99 report did not include this information! Mr. Patchye stated that future reports will include this data.
- 04/14/99 Discussed historic sample results w/ Jackylin Jones, Cambria, (510) 420-3315 & faxed her copies of some summary tables after reviewing files.

01/12/99 Called Owen Ratchye, Cambria Environmental, (510) 420-3316. He is the primary contact at Cambria. Cambria is still shooting for implementing the Soil Vapor Extraction System at the site by Feb '99, but there may be delays due to Bay Area Air Quality Mgmt. Districts' requirements for Cambria to notify all students at the public school, and located w/in 6000 ft of the site. They may want to wait to implement the SVE until groundwater levels go down in the spring. The State Trust Fund has already approved the workplan which was prepared by EEC's, Aug & dated Aug 30 1996. The State Trust Fund contact for the site is Lily Fung (916) ~~227-7019~~. Mr. Ratchye did confirm a slight swell in proximity to Well MW-2 that tends to pond some water. It is a few inches in depth, & will probably be leveled out in conjunction w/ the Soil Vapor Extraction work. A new quarterly monitoring report will be submitted w/in the next two weeks.
