Dear Mr. Fitzmaurice:

Smith Environmental Technologies Corporation has completed destruction of the three 2-inch diameter monitoring wells located at 2857 Hannah Street in Oakland, California. Subsequent to the final case closure of this site by the Regional Water Quality Control Board, abandonment of the wells was required by the Alameda County Department of Environmental Health and the Zone 7 Water Agency.

On 16 November 1995, the monitoring wells on the subject property were abandoned. Each well was destroyed as follows: the well cover and concrete seal were removed; the well was over-drilled using a truck mounted, eightinch diameter, hollow stem auger to remove the cement, bentonite seal, sand pack, and casing; the well bore was filled (through the hollow stem as the stem was withdrawn from the boring) with neat cement to within 1.5 feet of finished grade; and the remaining hole was filled with concrete.

The abandonment of the wells on the subject property has been conducted in accordance to the State of California Well Standards and Alameda County's Zone 7 regulations. For your records, a copy of the Department of Water Resources' Well Completion Report for the abandonment of the wells is enclosed. One Well Completion Report form was used for all three wells. If you have any questions, please feel free to contact me.




