Dear Mr. McNeil:

This letter serves to clarify the site identification number for the two properties referenced above. It will also affect some previous and all future charges for the County's oversight at these sites. As was meant to inform you, the previous Notice of Requirement to Reimburse (NORR) letter states that future billing for the County's oversight will be billed by the State Water Resources Control Board (SWRCB) through the Local Oversight Program (LOP) charges.

Because this site originally was identified as 4210 E. 12th St., it was given the new StID # (site identification number) 4880. When a release of petroleum contamination was observed during the tank removal, this site was transferred to the Local Oversight Program and you were notified in the NORR letter. Recently, our office was informed by Mr. Richard Asbe that this site was actually two sites with the addresses; 4210 E. 12th St. and 4201 E. 14th St. Since the release of petroleum was detected on the 4201 E. 14th St. site only, Mr. Asbe requested that the County formally close the 4210 E. 12th site. This can be done with the following conditions:

- 1. All previous LOP charges (charges after the site was transferred to LOP) to StID # 4880 will be changed to StID #101, the StID # for 4201 E. 14th St. You should disregard the Notice of Requirement to Reimburse for StID # 4880.
- 2. Our office will issue a NORR for 4201 E. 14th St. under StID
 # 101 since this address was previously given this number.
- 3. Our office will issue a closure letter for 4210 E. 12th St. once we have received a complete tank closure report from your contractor, Scott Company.
- 4. Our office has corrected the State Forms A and B to reflect that the 1000 gallon waste oil and the 350 gallon gasoline/diesel tank was located at the 4210 E. 14th St. location while the diesel tank and fuel oil tank were located at the 4201 E. 12th St. address.

Re: Request for Technical Reports for Tank Removals and Subsurface Investigation at 4210 E. 12th St., 94601

Dear Mr. McNeil:

As you are aware, the removal of four underground tanks has just been completed by Scott Company of California. Mr. Richard Asbe has been acting in your behalf and hopefully he has kept you abreast of its status. Our office will act in behalf of the Regional Water Quality Control Board (RWQCB) to oversee the investigation and cleanup of the above referenced site, since an unauthorized release of petroleum hydrocarbon has occurred. Enclosed please find an Unauthorized Leak Report (ULR) to be completed by you or your designee and returned to our office within 10 days or by May 11, 1994.

We have received faxxed analytical results for the soil samples taken at the time of the removals. Minimal soil contamination was found in the samples beneath the two tanks associated with the 4210 E. 12th St. address (closer to E. 12th St.), while obvious soil contamination and product release was observed in the former waste oil tank further north (closer to E. 14th St.) Considerable overexcavation was done in the area of the former waste oil tank and it appears that it was successful except for the west wall of the pit, where the side of the building prevented further excavation.

Mr. Asbe has requested, in your behalf, that our office provide written closure for the two tanks on the the south side of the property. He stated that this address is 4210 E. 12th St. and is actually different from that of the north area of the site where the two other tanks were removed. Our office is agreeable to this as long as you provide a closure report for these two tanks and an Assessor's site map verifying this information.

In the northern area of this site, you will be required to perform a groundwater investigation. Typically, a minimum of one monitoring well within ten feet of the former tank pit in the verified downgradient direction is required. Enclosed please find a copy of Appendix A, Workplan for Initial Subsurface Investigation. This is a guidance document from the RWQCB which details the common elements of a work plan.

I have also included, per Mr. Asbe's request, a list of consultants which have performed investigations on Alameda County sites. Please note the disclaimer associated with this list.

Please submit your tank closure report and a work plan for subsurface investigation to our office within 45 days or by June 14, 1994. This is a formal request for technical reports pursuant to the California Water Code Section 13267 (b). Failure to submit the requested documents may subject you to civil liability.
