Dear Mark Fetterman and Cherie McCaulou:

PG&E is providing a courtesy notification to the Alameda County LOP and Regional Water Quality Control Board Region 2 in regards to a replacement of a project at 155 Grand Ave Oakland, CA. The project scope involves removing 1,500 feet of 10-inch Aldyl-A distribution main from a 12-inch cast iron casing, and replacing it via insertion methods with 8-inch plastic main. Replacement of the Aldyl-A main with new main may require 10 on-pavement bell-hole excavations. Below is an approximate locations for the project.

The project includes excavations in or adjacent to the Lake Merritt Towers I & II (T0600100808) closed LUST Cleanup Site. Based on information available in Geotracker, residual soil contamination is present at these site. Construction is currently scheduled to occur in January 2016. Due to excavation taking place over contamination, all soil excavated in front of 155 Grand Avenue will be segregated, tested, and disposed of in accordance with the analytical results.

Could you please indicate if additional information is needed? PG&E appreciates your consideration and assistance with this matter.
